

THE ANNUAL REPORT ON ACTIVITIES OF THE CZECH STATISTICAL SOCIETY IN 2022

Members

The Czech Statistical Society (CStS) had 203 members as of December 31, 2022. The total number of members increased by eight during 2022 as ten new members joined and two members left the society.

The CStS annual meeting

The CStS annual meeting took place at the Czech Statistical Office (CZSO) in Prague on May 3, 2022. A total of 23 members participated. The 2021 activity report and the 2021 financial report were read and approved. Robert Šanda (CZSO) delivered a lecture on the *2021 Population Census in the international context and the use of administrative data sources*.

Other events (co)organised by the CStS

- **The meeting of the CStS expert group on the COVID-19 epidemic** was held at the Faculty of Management of the Prague University of Economics and Business in Jindřichuv Hradec on February 9, 2022. O. Vencalek, T. Fürst and A. Komarek summarised group activities and talked about current challenges. The event was streamed.
- **The 22nd JCMF summer school Robust** took place in Volyne on June 12-17, 2022. A total of 54 contributions were presented, including five invited talks and one tutorial on using supercomputers in statistics. A total of 78 participants took part: 62 from the Czech Republic, 12 from Slovakia, two from Switzerland, one from the USA and one from Nigeria.
- **Statistical Days in Telč** took place at the University Center of Masaryk University Brno in Telč on September 23 - 25, 2022. 32 participants attended it, and ten contributions were presented.
- **The St. Nicholas Statistical Day** was organized at the Prague University of Economics and Business on December 6, 2022. The event was streamed. There were 12 participants plus another 24 participants online. A total of four contributions were presented (three from the field of statistics).

Cooperation with the Czech Statistical Office

The Czech Statistical Office has been a long-term partner of the CStS and supports its activities by, for example, ensuring the printing of the CStS Information Bulletin and providing the society's registered office and the room for holding CStS annual meetings.

Membership in international organisations

Since 2011, our company has been a member of the Federation of European National Statistical Societies (FENStatS). CStS members are continuously informed about events in FENStatS. We received a subsidy for a membership fee of EUR 200 through the Council of Scientific Societies of the Czech Republic. We intend to proceed similarly in 2023.

Membership in the Council of Scientific Societies of the Czech Republic

The CStS is a member of the Council of Scientific Societies of the Czech Republic (RVS). The RVS plenary session was held in Prague on April 27, 2022. Jakub Fischer represented the CStS. The election of the RVS Executive Committee took place. Two more societies were accepted into the RVS. At the end of the year, a report on our society's activities was submitted to the RVS.

Other activities

- two regular issues of the CStS Information Bulletin were published.
- The society's website was regularly updated – 23 posts were published in the news section. Several updates have been made to other pages on our website.
- Representatives of the CStS Executive Committee, T. Hlavsa and O. Vencálek, took part in the 21st Slovak Statistical Conference held in Žilina on September 13-14, 2022.
